web a paralegal also known as a legal assistant or paralegal specialist is a professional who performs tasks that require knowledge of legal concepts but not the full expertise of a lawyer with a license to practice law the market for paralegals is broad including consultancies companies that have legal departments or that perform legislative web a paralegal is a person qualified by education training or work experience who is employed or retained by a lawyer law office corporation governmental agency or other entity and who performs specifically delegated substantive legal work web sep 8 2022 paralegals specific duties often vary depending on the area of law in which they work the following are examples of types of paralegals and legal assistants corporate paralegals for example often help lawyers prepare employee contracts shareholder agreements stock option plans and companies annual financial reports web apr 18 2023 paralegals can work on many of the legal tasks that an attorney would except those proscribed by law as long as they re supervised by a lawyer by taking on certain tasks like
